First of all, thank you once again for your invaluable support to Georgia.

Regarding your email and your questions, please be advised that:

1. Without preliminary signing relevant documents, the Ministry cannot officially issue the purchase order, but we provided you with official request regarding the medicines.
2. The exact delivery address, as mentioned in draft MOU, is CIP Tbilisi International Airport. Furthermore government has two main warehouses with address as follows:
 - a. #21a Kavtaradze st., Tbilisi, Georgia, and
 - b. #5 Kisikhi st., Tbilisi Georgia.
3. The exact billing address will be: #144, Tsereteli ave. 0159, Tbilisi Georgia. The Receiver will be LEPL of the Ministry of Labour, Health and Social Affairs of Georgia - Social Service Agency.
4. Attached please find our request and description of requirements of warehouses.

Furthermore, we have some technical issues to resolve:


As the receiver of the medicinal products will be LEPL Social Service Agency and if it will be possible, could we also sign separate document in order for Social Service Agency to be able to make the custom clearance of the medication.

We are going to need to get confirmed invoice in the name of Social Service Agency before the delivery of the medications. Invoice must include the name of the medication, quantity, unit price (even symbolic one) and indication that the goods are free of charge. Also for the custom clearance we are going to need following documentation: original invoice, packing list, certificate of origin, quality certificate and airway bill.
